Attendance is mandatory. You must be present on the first day of class. Inappropriate behavior will result in the loss of your opportunity to take this class. Please consider extra-curricular activities when registering for this class.

A student can't miss more than 3 hours of class time. If a student misses more than 3 hours of class time, they will be dropped from the class. The state of North Carolina requires that a student attends 30 hours of classroom training and 6 hours of behind the wheel training to receive a permit to drive. School dropouts are not allowed to enroll. Return form to Mrs. Mitchell in the main office with the \$65.00 CASH and you will be registered. THIS SCHEDULE IS SUBJECT TO CHANGE. If class is canceled for any reason, the schedule will be extended as needed to reflect the number of days missed. This includes, but is not limited to weather related issues. If you are a homeschool student, you are now required to turn in a Homeschool Verification Form. This form can be found on your homeschool website. This form must be turned in before being allowed to take the class.

The \$65 registration fee must be paid by August 9, 2021 (7 days prior to the  $1^{st}$  class). Students facing an economic hardship and participating in the free and reduced lunch program may apply for a reduced rate of \$50. If applying for an economic hardship, the application, \$50 cash, and reduced rate form must be turned in by August 5, 2021.

- Current CECHS students can begin registering May 10, 2021
- CECHS incoming freshman can begin registering June 14, 2021
- Non CECHS students can begin registering July 26, 2021

## **Driver and Traffic Safety Education Class Rules**

- 1. Bring all needed material to class
- 2. Be in your seat and ready to start class at the beginning of class and after break
- 3. Keep your hands, feet and all objects to yourself
- 4. All school rules apply while you are attending Driver Education class
- 5. No food or drinks are allowed in the classroom
- To receive a Driver Education Certificate of completion in North Carolina state law requires you to satisfactorily complete 30 hours of classroom instruction and 6 hours of behind-the-wheel instruction
- 7. Attendance is MANDATORY! One <u>excused</u> absence not to exceed 3 hours is allowed. However, all time missed must be made up before a classroom grade can be averaged. If a student is absent for more than 3 hours, that student will be dismissed from class and cannot repeat the class
- 8. Your behavior in the class will determine whether or not you are allowed to continue to attend Driver Education classes
- 9. Under state law, North Carolina public, private and home-schooled students are given one opportunity to satisfactorily complete Driver Education. Students who fail Driver Education may not repeat the course.
- 10. Transportation is your responsibility. Have your ride waiting in the parking lot promptly at the end of class. Students who are unable to leave on time will be told not to return to the Driver Education class
- 11. Failure to comply with these rules will result in dismissal from the Driver Education class
- 12. Driver Education fee is non-refundable
